



### 1. INTRODUCTION

The HIMCAPES' College of Law is an exciting new development in the field of legal education in the State of H.P. In a short span of time Period, the college has made an institution with a distinguished reputation for itself by earning laurels with excellent performance of its students in examinations conducted by the HP University. The college is located in Una District of Himachal Pradesh. With sprawling campus, HIMCAPES is gorgeously positioned at a hilltop presenting a picturesque view for all. Backed by young and dynamic faculty, excellent academic and co-curricular facilities, HIMCAPES boasts of an educational environment with a high quality learning experience.

"We believe legal education is not merely confined to class room teaching. We ensure to provide multidimensional learning experiences which integrate rigorous academic, applied, practical and cross-disciplinary perspectives to ensure a deep understanding of law in all its contexts. We provide academic environment which stimulates out of box thinking among our students."

Started under the aegis of the H.P. State Co-operative Advancement of Professional Education Society, the HIMCAPES' College of Law is a self financing professional college affiliated to H.P. University and recognized by the Bar Council of India. The University and the Bar Council of India have allotted 80 seats per annum for B. A. LL.B. (Hons.) five years integrated degree course and 60 seats for LL.B. three years degree course.

### 2. LOCATION

The HIMCAPES' College of Law is located at Badhera, Tehsil Haroli, District Una, H.P. It is approximately 11 kms. from main Bus-Stand, Una on Una- Haroli road. The College of Law is well-connected with the road having adequate transport facility in the area. Public transport facility is available from 6.00 a.m. to 9 p.m. The railway station Una is situating at a distance of 12 kms. with computerized reservation facility to entire country.

### 3. THE CAMPUS

It is natural for students to expect a bewitching environment and a sprawling campus for institutions claiming to demonstrate excellence in academic pursuits. The HICAPES has developed a sprawling campus spreading over 70 kanals at Badhera by using state of the art technology. The environment here is calm and ideal for studying. The buildings of College of Law have been set up on a hilltop with large landscape and greenery all around. HIMCAPES fully believes that "Cleanliness is a stepping stone to success. Therefore HIMCAPES firmly supports & work on 'Swachch Bharat Abhiyan' which is a clean India Campaign run by the Govt. of India to achieve the goal of cleanliness and hygiene.

### 4. SIGNIFICANCE OF STUDY OF LAW

In a democratic welfare society, the significance of legal education cannot be overemphasised. In a democracy where essence of civil society is rule of law, law defends and promotes individual, the individual being the unit of society, social welfare is merely a shorthand description of the welfare of the individuals who constitute the society. In such a society, law serves as an instrument to achieve socio-economic development. Today, law is viewed not merely as an instrument of social control but also as an instrument of social change. Like liberal education, legal education presupposes to serve the society by imparting law student general and cultural education making them disciplined law abiding citizens. As a professional education, legal education equips law students for playing different roles in society and discharging various law jobs, the range and scope of which are always expanding in the modern democratic society. Accordingly, it is realized in modern India that legal education ought to have breadth, depth and wide perspective.

### 6. ADMISSION SCHEDULE

The admission schedule for B.A. LL.B. (Hons.) five years and LL.B Three years degree course viz. last date for receipt and Application Form and date(s) of interview or counseling shall be that as may be specified or notified by the H.P. university.

- **Note:** 1. The candidates interested to seek admission to B.A.LL.B. (Hons.) Five years integrated degree course/LL.B. Three Years Degree Course shall be required to fill up the Admission Form appended to this Prospectus and submit the same to the Principal, HIMCAPES' College of Law.
  - 2. On the date of counseling, candidates shall appear before the interview/admission committee along with original certificates of Matriculation, character issued by the school or college last attended and 10+2 or graduation or equivalent exams, as the case may be. The candidates belonging to SC/ST category shall bring a certificate to this effect issued by a competent authority.

<sup>\*</sup>Interview/counseling shall be held at the college campus.

### 7. PROCEDURE FOR SEEKING ADMISSION

- 1. Admission to the course shall be made strictly on the basis of academic merit of a candidate, based on marks obtained by him in 10+2 for his consideration to B.A. LL. B. (Hons.) degree course and in graduation or equivalent examination for LL.B. three years degree course.
- 2. The first merit list in respect of each course shall be prepared and displayed after conducting interview or counseling. The final list of merit shall be displayed on the notice board of HIMCAPES after second counseling.
- 3. The candidates seeking admission to any of the course shall be required to fill in an admission form appended to this prospectus and submit the same along with attested copies of the certificates of matriculation examination, the proof of date of birth, 10+2 examination or graduation or equivalent examination to the Principal, HIMCAPES' College of Law on or before the last date declared by H.P.U. The selected candidates shall be required to pay the tuition fee, admission fee and university charges on the spot as per fee structure of the college on the date of interview/ counseling, failing which his/her right to admission shall stand cancelled and the seat will be allotted to the next candidate in order of merit.
- 4. The fee once deposited shall not be refunded under any circumstances.
- 5. The last date of admission with the special permission of the Vice-Chancellor of the H.P. University shall be (as specified/declared by V.C.)

### 8. BASIS OF ADMISSION

- (a) The admission to the B.A. LL.B. (Hons.) five years Integrated degree course shall be made on the basis of Academic Merit. Candidates who have passed 10+2 or an equivalent examination securing minimum 50% marks (45% in case of SC/ST) in aggregate of total marks from any university or Board or Council recognized by Law in India shall be eligible to apply for admission. Candidates awaiting result of 10+2 may also apply. However, they will have to produce original pass certificates of 10+2 at the time of interview/counseling.
- (b) The admission to the LL.B. three year degree course shall be made on the basis of academic merit. Candidates who have passed graduation/degree examination or an equivalent examination securing minimum 45% marks (40% in cause of SC/ST) in aggregate of total marks from any University recognized by law in India shall be eligible to apply for admission. Candidate awaiting results of degree examination or equivalent may also apply.

### 9. INTAKE AND RESERVATION

### The reservation for admission shall be as under:-

- (1) 75% seats shall be reserved for those candidates who have passed their qualifying examination from any of the recognized schools/ colleges located in the State of Himachal Pradesh. The remaining 25% seats shall be open for all.
- (2) 15% seats shall be reserved for candidates belonging to Scheduled Castes of Himachal Pradesh.
- (3) 7.5% seats shall be reserved for candidates belonging to Scheduled Tribes of the State of Himachal Pradesh.

(4) 3% of seats shall be reserved for orthopaedically handicapped candidates of Himachal Pradesh with 40% disability to be certified by the Head, Department of Orthopaedics of a recognized Medical College in the State.

**N.B.**: The management of HIMCAPES' College of Law may, at its discretion, convert any or all its non-subsidized seats into subsidized seats.

### 11. **AGE**

- A) A candidate seeking admission to the B.A.LL.B (Hons.) five year Degree Course should not have completed 20 years of age in respect of general category and 22 years of age in respect of candidate belonging to SC/ST category as on 1st July on the year of admission and 5% seats are reserved for physically handicapped candidates.
- B) A candidate seeking admission to the LL.B. three years course should not have completed the age of 26 years as on the 1st July on the year of admission. In service candidates (Govt. & Pvt.) shall also be eligible to apply for LL.B. degree course subject to the production of NOC from their employer/deptt. only subject to the satisfaction of Principal/Management of HIMCAPES. There shall be no age bar for in-service candidates.
- C) The Vice-Chancellor of the H.P. University has the power to allow age relaxation for a maximum period of six months.

### 12. RESOLVING A TIE

In case of a tie between the candidates for admission, the matter shall be resolved as per the procedure and norms applicable in H.P. University for such matter.

### 13. ROASTER FOR ADMISSION AND RESERVATION

The HIMCAPES' College of Law follows the same reservation criterion and roaster for admission of students in degree course as is followed by the H.P. University.

Failing which his/her right to admission shall stand cancelled and the seat will be allotted to the next eligible candidate. As regards payment of other charges, the same shall be paid by the student on or before date mentioned by the College. A late fee fine of Rs. 50/- per day shall be charged in case the student fails to deposit the requisite fee on or before the specified date. It should be noted carefully that a student will not be allowed to sit in the semester examination if he fails to pay the requisite fee or clear other dues within the specified period.

\*Students availing hostel facility shall have to pay hostel charges separately in addition to above charges.

"The College of law endeavours to impart legal literacy among the masses through organizing legal aid camps besides inculcating a sense of discipline, personal character, responsibility, ethical and moral values and a spirit of national integration in the students to serve the country."

### 16. SCHEME OF THE COURSE

- A) B.A. LL.B. (Hons.) five years integrated degree course shall have papers spreading over ten semesters. Each paper carries 100 marks, out of which 70 marks are assigned for theory paper and the remaining 30 marks are allocated for internal assessment i.e. mid-semester examination, home assignments, Moot Court presentation, attendance and viva.
- B) LL.B. three years degree course shall have papers spreading over six semesters. Each paper carries 100 marks, out of which 80 marks are assigned for theory paper and remaining 20 marks for internal assessment.

"In order to enable students to comprehend the practical aspects of law, regular visits to Supreme Court, High Court, Consumer Forums, Labour and Revenue Courts, Lok Adalats, etc. has been made an essential part of day-to day curriculum."

### 18. ATTENDANCE

In order to be eligible to appear at University examinations, a student is required to have at least 75% attendance in each course, in theory as well as in practical. Shortage of attendance in any course(s) may be condoned by the Principal up to a maximum of 15% in each course or 9% in the aggregate provided he/she has attended at least 66% of the lecturers in the aggregate of the lectures for the semester. However, the percentage of lecture attended in each course shall not in any case fall short of 60%.

"A Moot Court has been set up to acquaint the students with the procedural and functional behaviour of law. The College of Law has established a Legal Aid Center for providing free help and guidance to needy persons."

### 19. EXAMINATION

There shall be an examination at the end of each semester to be conducted by the Himachal Pradesh University in respect of each degree course. A student clearing all the ten semester examinations of five years integrated course shall be conferred the Degree of B.A.LL.B. (Hons.) by the H.P. University, Shimla. Similarly, a student clearing all the six semester examinations of three years course shall be conferred the Degree of LL.B. by the H.P. University.

### 20. ACADEMIC CALENDAR

Regular teaching of 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup>, and 9<sup>th</sup> semesters will commence from as per HPU Academic Schedule which is issued and uploaded on the HPU website in the begning of each Academic year.

### 21. TEACHING METHODOLOGY

The teaching methodology adopted at the College of law is intensive as well as extensive classroom teaching involving active participation of the students. Theoretical classroom teaching is supplemented by clinical legal work. It also includes preparation of project reports, project presentation, submission of assignments, seminars, moot courts, etc. The students are awarded for the best academic and professional performances. The achievements of our students have been outstanding, who have bagged top ten positions repeatedly in the entire university. For All (Male/Female) Students: Black Trousers, White Shirt, Black Tie with insignia of HIMCAPES, Black Coat of Single Chest with insignia of HIMCAPES, Black Shoes and Black Socks

### 27. PROMOTION RULES: H.P.UNIVERSITY ORDINANCE 12.8 (A) TO 12.12(A)

12.8(A):A candidate is required to pass in all the courses of B.A.LL.B.(Hons.) in each semester Provided that:

- (i) A candidate who appears in the examination and fails to obtain pass marks in any course in the first semester, may be permitted to proceed to the second semester but shall not be permitted to proceed from the second to the third semester without appearing in the examination and having qualified 50% of the total number of course prescribed for first and second semester taken together.
- (ii) At the time of third semester examination the candidate may appear in the course (s) in which he/she may have failed to and also in all courses prescribed for the third semester. But he shall not be permitted to proceed from the third semester to the fourth semester without appearing in the examination.
- (iii) At the time of fourth semester examination a candidate may appear in course (s) which he/she may have failed to obtain pass marks in second semester and also in all course the courses prescribed for the fourth semester but he shall not be permitted to proceed from the fourth semester to the fifth semester without appearing in the examination and having qualified 50% of the courses of third and fourth semester taken together and all course of first and second semester.
- (iv) At the time of fifth semester examination a candidate may appear in the course (s) in which

he/she may have failed to obtain pass marks in the third semester and also in all courses prescribed for the fifth semester. But he shall not be permitted to proceed from the fifth to the sixth semester without appearing in the examination.

- (v) At the time of sixth semester examination a candidate may appear in the course (s) which he/she may have failed to obtain pass marks in fourth semester and also in all course the courses prescribed for the sixth semester but he shall not be permitted to proceed from the sixth semester to the seven semester without appearing in the examination and having qualified 50% of the courses of fifth and Sixth semester taken together and all course of third and fourth semester.
- (vi) At the time of seven semester examination a candidate may appear in the course (s) in which he/she may have failed to obtain pass marks in the fifth semester and also in all courses prescribed for the seventh semester. But he shall not be permitted to proceed from the seventh to the eighth semester without appearing in the examination.
- (vii) At the time of eighth semester examination a candidate may appear in course (s) which he/she may have failed to obtain pass marks in sixth semester and also in all courses the courses prescribed for the eighth semester but he shall not be permitted to proceed from the eighth semester to the ninth semester without appearing in the examination and having qualified 50% of the courses of seventh and eighth semester taken together and all course of fifth and sixth semester.
- (viii) At the time of ninth semester examination a candidate may appear in the course (s) in which he/she may have failed to obtain pass marks in the seven semesters and also in all courses prescribed for the ninth semester. But he shall not be permitted to proceed from the ninth to the tenth semester without appearing in the examination.
- (ix) At the time of tenth semester examination a candidate may appear in the course (s) in which he/she may have failed to obtain pass marks in the eight semester and also in all courses prescribed for the tenth semester.
- 12.9(A) A candidate shall not be declared successful to pass the B.A.LL.B. (Hons) examination unless he obtains at least pass marks in all the courses prescribed for all the ten semesters including practical training courses.
- 12.10(A) A candidate who is unable to pass the B.A.LL.B. (Hons) examination on account of his having obtained less than pass marks in any course or having been unsuccessful in the prescribed practical training courses, may re-appear in the corresponding semester examination of the following year in the course in which he may have failed to obtain pass marks or complete the practical training prescribed for the relevant semester which he could not successfully do earlier.
- 12.11(A) A candidate who obtains pass marks in all the course prescribed for the first six semesters, shall be eligible for the award of Bachelor of Arts Degree in Law (Academic). A candidate who is unable to obtain this Degree on account of his having obtained less than the pass marks in any course, may re- appear in the corresponding semester examination of the following year in the course in which he failed to obtain pass marks earlier.
- 12.12(A) A candidate who does not obtain the B.A. Degree in Law in five years or B.A.LL.B. (Hons) degree in eight years including the time allowed as late college student shall cease to be a candidate.

### 28. CONDUCTAND DISCIPLINE

1. Student shall abide by the general and special rules made by the HIMCAPES' College of Law from time to time with regard to the conduct of students, in and outside the college, and in case of

misconduct, the decision of the college Authorities shall be final. Parents and guardians are also presumed to have agreed to these rules when their wards join the college.

- 2. The student shall have to strictly follow the time table of the HIMCAPES' College of Law.
- 3. Students should read the 'Notices' displayed on the College Notice Boards from time to time.
- 4. The student coming late or leaving the College before teaching hours shall be liable for indiscipline and shall be punished for his/her act of indiscipline under the rules and regulations of the HIMCAPES' College of Law.
- 5. A student involved in the violation of any of the rules and regulations of the College of Law/ University or in any way found involved in any act of indiscipline may be placed on conduct probation by the Principal of the College of Law. If a student, who has been on conduct probation on the previous occasion, commits an act of indiscipline, he/ she shall be expelled from the College of Law
- 6. There shall be no ragging in and outside the campus of the College of Law and also on roads / approaches leading to the College of Law. Any student who aids or abets such an act shall be guilty of ragging and liable to be expelled from the College of Law besides criminal prosecution.
- 7. If a student is found directly or indirectly indulging in ragging, the Principal, after due enquiry, if satisfied, shall have the power to expel the guilty student(s) from the College of Law.
- 8. A student who is expelled from the College of Law shall not be allowed to appear in any examination during the academic year in which he/she is expelled.
- 9. Each case of the expulsion shall be reported to the Vice-Chancellor of the University immediately after the order is passed. A certificate signed by the Principal of the College to the effect that the student has been given adequate and reasonable opportunity to explain his/her position before the order was passed, shall accompany the report.
- 10. Smoking, Consumption of alcoholic drinks, intricate and narcotic drugs and being in possession of any such material shall be strictly prohibited in the college premises and would entail disciplinary action against the erring student.
- 11. In case of illness, a student/parent/guardian must give application with medical certificate to the office.
- 12. Students must not loiter in the college premises while lectures are being engaged.
- 13. No students in allowed to bring eatables and cold drinks in the classroom, library.
- 14. The Principal shall have power under H.P. University ordinance to impose a fine in case he/she remains absent from the college without prior permission.
- 15. Any student found violating the Dress code shall be liable to pay fine of Rs. 100 at the first instance and on the repetition of the same fine of Rs. 200 will be imposed on him.
- 16. Notwithstanding anything in these rules the students will have to abide by the Provisions of H.P. University Act, Statutes, Ordinances, Rules and Regulations as may be framed and amended from time to time.
- 17. In any matter involving punishment, an appeal shall lie to the University if preferred within fifteen days of the decision.
- 18. Making false statement or tempering with certificates and records, when applying for seeking admission or securing any other benefit will entail punitive action.

In addition, the student shall,-

- 1. be respectful to teachers, staff members and the management of HIMCAPES;
- 2. be appropriately dressed in uniform for classes;
- 3. not to indulge in smoking or drinking;
- 4. keep the campus clean and pollution free;
- 5. take pride in being an alumni of HIMCAPES college of law and aim for excellence;
- 6. be extremely regular as well as punctual in all classes;
- 7. treat HIMCAPES property with utmost care and help in its upkeep; and
- 8. not to participate in any political, anti-national, anti-social or undesirable activity in or outside the campus.

The HIMCAPES' College of Law insists on high standard of discipline from the students for enhancing the status and reputation of this center in legal education. The Principal may, in consultation with other faculty members, lay down, from time to time, norms and standards for students behavior. The Principal shall be the final authority to take necessary action in case of violation of the rules and regulations specified by the college of law or directions issued from time to time by the University.

### 29. COLLEGE MANAGEMENT COMMITTEE:

The composition of the management of college of law shall be as under:

- 1. Chairman of the HIMCAPES
- 2. Vice-Chairman of the HIMCAPES
- 3. Honorary Secretary/CEO of the HIMCAPES
- 4. Principal of the College of Law;
- 5. Two representatives of the teaching staff of the College of Law;
- 6. One representative of the non teaching employees of the College of Law;
- 7. One representative of the Director of Education not below the rank of the Principal;
- 8. Two nominees of the Himachal Pradesh University to be nominated by the Vice-Chancellor of HPU;
- 9. One Government Officer of the region concerned not below the rank of Sub-Divisional Magistrate;
- 10. Local member of the Legislative Assembly H.P. of the concerned constituency
- 11. One representative of the person who has donated a sum of Rs.1,00,000/- or above;
- 12. President of the Students Central Association of the College of Law, if any.

### 30. STUDENTS' ADVISORY COMMITTEE

The composition of the Students' Advisory Committee shall be as follows:-

- (1) Patron-in-Chief: Principal, HIMCAPES' College of Law.
- (2) Two teachers and one non-teaching employee to be nominated by the Principal.
- (3) Two members each from all the year such as 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> on the basis of their academic performance in examination such as 1<sup>st</sup> Topper and 2<sup>nd</sup> Topper.
- (4) Student advisory committee shall assist and help the authorities to redress the grievances of

the students or submit any suggestion for the betterment of the institute and to organize extracurricular activities such as Moot Court Competitions, Educational Tours, etc.

### 31. VENUE FOR INTERVIEW/COUNSELING

The interview/counseling shall be held at HIMCAPES' College of Law Badhera, Tehsil Haroli, Distt. Una H.P firstly on the date & time notified and/or informed by the college from time to time. No separate information shall be sent to the candidates to this effect.

### 32. GENERAL PROVISIONS

The students shall be bound by the provisions of the Himachal Pradesh University Act, Statutes, Ordinances, Rules and Regulations as may be framed or amended from time to time.

### 33. HOSTEL RULES

- 1. Ragging is strictly prohibited in and outside the institute.
- 2. Rooms to the students will be issued by the warden.
- 3. No boarders is allowed to shift furniture from one room to another.
- 4. Boarders are responsible for cleanliness and good keep up of rooms. The rooms can be inspected by warden at any time.
- 5. Study time from 8:30 p.m. to 10.30 p.m. is compulsory for the students and would be inspected by the warden.
- 6. Any damage to room or furniture should be reported to warden immediately.
- 7. No border will remain absent from hostel without written permission of warden.
- 8. Every hosteller should make entry in the departure register before leaving the hostel.
- 9. All lights and fans must be switched off while leaving the room.
- 10. Boarders are not allowed to keep valuables, excessive cash and gold jewelry in the hostel.
- 11. No intoxicants/ alcoholic drinks are allowed in the hostel.
- 12. No one is allowed to use abusive language in the hostel.
- 13. Boarders are not allowed to conduct meetings/strikes in hostel. In case any boarder is found guilty, she/he will be expelled from college and hostel.
- 14. All boarders must be present for attendance at 7.30 pm.
- 15. No electric appliances such as heater, iron, TV, heat convector, electric rod are allowed in room, if found guilty, the concerned boarder will be fined.
- 16. Main gate will be locked at 9.00 p.m.

### 34. RULES FOR VISITORS

- 1. A list of visitors with their photographs should be deposited by parents at the time of admission.
- 2. No male/female visitor is allowed in the room.
